Request for access to documents concerning the ECB and the G30

Dear Mr Haar,

On 8 October 2015 you requested access to documents regarding the participation of ECB staff in the Group of Thirty (G30). You also made a reference to the Code of Conduct for the members of the Governing Council¹ as well as the Supplementary Code of Ethics Criteria for the members of the Executive Board² in this regard. You then specifically requested a list of the cases on which the Ethics Officer, the Ethics Adviser, and the Ethics Committee have passed decisions since January 2002. On 4 November 2015, in line with Article 7(3) of Decision ECB/2004/3,³ the ECB extended the stipulated time limit by which it was to reply to your request by an additional 20 working days, due to a temporary overload of incoming requests.

With regard to your questions on (1) whether the participation of ECB staff in the activities of the G30 has been addressed in any way by persons charged with the task to ensure compliance with ethics rules, and (2) whether the recently established Ethics Committee has addressed any issues concerning the participation of ECB staff in activities of the G30 (including the ECB President and a Member of the Supervisory Board, Ms Julie Dickson), please be informed that no such document exists. We would like to clarify that members of the ECB decision-making bodies are not assimilated to the ECB staff. To the best of our knowledge, members of the ECB staff do not participate in the G30.

With regard to your request to obtain access to a list of cases on which the Ethics Officer, the Ethics Adviser and the Ethics Committee have passed decisions since January 2002, please note that the advice given by the ECB's Ethics Adviser and the ECB's Ethics Officer does not exist as a list of cases. Still, with a view to be helpful, we have undertaken the effort to create a document which presents the categories of advice that was provided from 2001 to 2014 (see annex). However, please note that the approach of the Ethics Adviser differed from that of the Ethics Officer. While the Ethics Adviser created a new case for each instance of consultation, the Ethics Officer opted for establishing landmark cases only to which he referred to in his practice later on. As a result, the table below does not reflect all pieces of advice given by the Ethics Officer, but only the landmark decisions that at the time were accessible in the ECB's intranet.⁴

As of the date of your request, the Ethics Committee had issued its advice on two occasions⁵; in both cases the matter concerned activities undertaken in a personal capacity.

For the sake of good order, we draw your attention to Article 10 of ECB Decision ECB/2004/3, which provides that "[D]ocuments released shall not be reproduced or exploited for commercial purposes without the ECB's prior specific authorisation. The ECB may withhold such authorisation without stating reasons."
